Subject: Complaint seeking registration of FIR regarding hit-and-run collision caused by an armoured vehicle (Casper).

Respected Sir,

I, T. Mohindro Singh, son of (L) T. Shyamkishore Singh, resident of Wangkhei Angom Leikai, Imphal East, presently employed as an official driver attached to the office of the Deputy Secretary, Manipur Legislative Assembly, respectfully submit this complaint for your kind consideration and necessary action.

On 9th June, 2026 at approximately 11:58 am, I was driving the official vehicle bearing Registration No. MN-01AX-7592 (Suzuki Ciaz) carrying Smt Gurumayum Bandana Sharma, Deputy Secretary, Manipur Legislative Assembly, on official duty along NH 39 Kangla Park Road in between IMC and MG Avenue traffic crossing, Imphal West.

While proceeding on the road in a lawful and careful manner, an armoured vehicle (Casper) moving behind our vehicle suddenly hit the right rear portion of the said official vehicle. Due to the impact, the rear right-side door and adjoining body panel of the official vehicle sustained substantial damage.

Immediately after causing the collision, the driver of the armoured vehicle (Casper) failed to stop and continued driving away from the scene without making any effort to ascertain the condition of the occupants or the extent of damage caused to the vehicle. Such conduct was highly negligent, irresponsible, and posed a serious threat to the safety of road users.

At the time of the incident, the Deputy Secretary, Manipur Legislative Assembly, was travelling in the vehicle. The hit and run incidence could have resulted in serious injury or even loss of life. Fortunately, no major physical injury occurred, but the incident caused considerable distress and damage to government vehicle and serious mental trauma to the said officer and myself who were travelling in the said vehicle.

Photographs of the armoured vehicle (Casper) and the damage caused to the official vehicle were taken immediately after the incident and are enclosed herewith as supporting evidence.

In view of the above facts and circumstances, I respectfully request your good office to take immediate and appropriate action in accordance with law, in the interest of justice.
