It is reported for your strictly immediate action on the incident that occurred in Congress Bhawan, Imphal, name shri Ningthoujam Popilal assaulted me without reason. It is truly attempt to murder and defaming my political career as well. The incident took place in presence of vice-president, MPCC Shri Amin Shah, Shri Tarh Johny, IYC General Secretary, Smt. Elangbam Monika Devi, Vice- President, PYC and also Deepu Singh, President Keishamthong Assembly Youth Congress.

It is true that senior leaders of Congress Party were in First Floor, Main building at Congress Bhawan. Hon'ble President MPCC also was in Congress office when the incident happened.

It is shockingly heinous and violet crime attempting to murder physically and assaulted me. It is very doubtful and very suspected that he is trying for more physical assault to me in the future.

So, I do request you to take immediate necessary actions on the above matter. The incident occurred at around 5:30 pm on 24<sup>th</sup> June, 2026 at Congress Bhawan, Imphal.
