Subject: Complaint report regarding the theft of a battery from a
diesel auto.

Sir,

I have the honor to submit this complaint for your kind consideration and necessary legal action.

On 06/07/2026, at approximately 3:30 PM, I attempted to start my diesel auto, which was parked in front of the Manipur Fire Service, Imphal. Upon finding that the engine would not start, I inspected the vehicle and discovered that the battery had been stolen. I had left the auto parked for only about 10 minutes.

Immediately upon discovering the theft, I informed my fellow drivers in the vicinity and initiated a search. I proceeded towards the BT Park crossing on the western side of the Johnstone Higher Secondary School. Upon reaching the area, I observed a crowd surrounding an individual. Upon investigation, I found my stolen battery in the possession of the individual.

The person was immediately apprehended by a team of City Police team and brought to the City Police Station along with the recovered property for further legal formalities. The value of the battery is about Rs 3500/-.

I request you to kindly register a case against the individual and take necessary legal action as per the law.
