1. It is submitted that based on specific intelligence regarding the movement of KNF(MC) cadres/ individuals carrying illegal ammunition troops of 2 JAKLI (SHERWANI) along with G/58Bn & E/58 Bn CRPF established a MVCP in the area of P Geljang on 06 July 2026 from 0030 hours.
2. During checking of vehicles and individuals at the MVCP two suspicious individuals were intercepted. On noticing the Security Forces they tried to flee from the spot and discarded a bag while escaping. Upon investigation of the discarded bag a total of 77 nos of 5.56mm live rounds were recovered and seized at 0115 hrs.
3. The alert troops immediately pursued and apprehended both the individuals who identified themselves Janggoulen (17) of Khokheng Village and Chonminkai (18) of Boljol Village at 0130 hrs.
4. The apprehended KNF(MC) cadres along with the recovered items were subsequently handed over to Churachandpur Police Station for further investigation and necessary legal action.

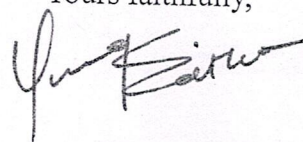
