11. First Information contents: Today i.e. 5/7/2026 at 12:20 am, received an information that on the same day at around 12:10 am, one TVS NTORQ scooter bearing Regn.no. MN06SG-3466 proceeding from Wangjing towards Thoubal dashed into the back of a stationary vehicle Maruti Van bearing Regn. No. MN03P 0345 parked on the left side of the road and it was occurred at Wangjing near Toll Tax booth along NH102. As a result of it, unknown male pillion rider and one unknown male pillion rider of the said TVS NTORQ scooter sustained injuries and were evacuated to the District Hospital Thoubal for medical treatment. However, the rider was declared brought dead. Both vehicles were also partly damaged. Hence the case.
