As a result of it, both unknown driver and rider of both vehicles and one pillion rider of Honda Activa b/regn.no. MN04D3121 sustain injury on their persons and were evacuated to the District Hospital Thoubal for medical treatment. Both vehicles were also badly damaged. Hence the case.
