Sir,

I have the honour to report that today i.e. 23/07/2025 at about 10:50 a.m. while I was on conducting frisking and checking duty at Sorojini Oil Pump Opposite Wangbal IVR road area, in that one Honda Activa 5G Grey in colour bearing registration number MN04G1095 was coming from Wangbal Mayai Leikai Canal side towards Wangjing side in a very suspicious manner. Due to his suspicious nature, the Honda Activa was stopped and detained the rider for verification.

On preliminary verification, he identified himself as Saikhom Shidan Singh @Romen (35) yrs. s/o. Late S. Santo Singh of Heirok Part-I, Heituppokpi, Thoubal District a gang member of vehicle lifter. On further checking the Honda Activa 5G Grey in colour bearing registration number MN04G1095 without key is suspected to be stolen vehicle one. On further verification he disclosed that he and his associate Mr. Rakesh of Lamding Laishram Leikai had lifted the said Honda Activa 5G Grey in colour bearing registration number MN04G1095 from Wangbal Mayai Leikai and seized the above mentioned Honda Activa 5G Grey in colour bearing registration number MN04G1095 without key at 11:00 am by observing formalities.

Hence, he was arrested at 11:02 a.m. of 23/07/2026 from the spot Sorojini Oil Pump Opposite Wangbal IVR road of the same day by observing formalities.

It may be mentioned that all the necessary formalities under the BNSS were duly observe, including preparation of Arrest Memo and Seizure Memo, and the entire proceedings were video graphed and recorded through e-Sakshya portal at the spot.

The arrested person mentioned above along with the Honda Activa 5G is handed over to you for taking further legal action against him.
