I, **Moirangthem Rajmani Singh**, aged about 50 years, S/o Shri M. Tombi Singh, resident of Heirok Part-I, Heituppokpi, MamangLeikai, P.O. Wangjing P.S. Heirok, District Thoubal, Manipur, respectfully submit this complaint as follows:

That I was serving as the **Member, Administrative Committee, 7-Heirok Zilla Parishad**. At the request of the Heituppokpi Youth Organisation (HYO), the local Meira Paibees, and the people of the locality, I extended private financial assistance for the construction of fencing around the HYO playground by using iron poles and netting wire. The total expenditure incurred towards the construction, including the cost of materials, labour, and transportation, is more than **Rs. 1,15,000/- (Rupees one lakh fifteen thousand)**.

That on **18th July, 2026, at about 7:30 A.M.**, while the construction work was in progress, the following persons, namely:

1. **Shaikhom Naobicha Singh**, aged about 37 years, S/o Shri Madhumangol Singh, resident of Heirok Part-I, HeituppokpiLeikai, VDF (Heirok), No. 131 B Company;

The above illegal acts were committed under the direction and leadership of **Shaikhom Naobicha Singh** and **Shaikhom Premkumar Singh** in collusion with the other accused persons with a mala fide intention to damage the developmental work and to tarnish my image and reputation for their personal and political interests, thereby causing me substantial financial loss.

I, therefore, respectfully request you to kindly register a criminal case, conduct a proper investigation, recover the dismantled fencing materials, seize the JCB machine used in the commission of the offence if necessary, and take appropriate legal action against all the accused persons in accordance with the law.

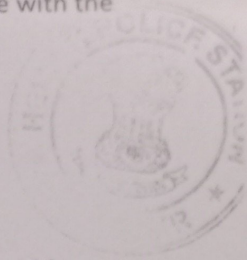
