I, **Thokchom Lakham Devi**, aged about 42 years, W/o **Shri Thokchom Basanta Singh**, resident of Heirol Part-I, Heituppokpi Leikai, P.O. Wangjing, P.S. Heirol, District Thoubal, Manipur, respectfully submit this representation as follows:

1. That a false complaint dated **18th July 2026** was submitted by one **Moirangthem Rajmani Singh** against my husband, **Shri Thokchom Basanta Singh** (listed as Accused No. 7), and others, resulting in the registration of **FIR No. 18(7)2026 HRK-PS** under Sections 324(5), 61(2), and 3(5) of BNS, 2023 and Section 3(1) of the PDPP Act, 1984. Pursuant to this, a

Notice under Section 35(3) of BNSS, 2023 dated 22/07/2026 (Ref: M.NO. 638/HRK-PS/2026) was served to my husband directing him to appear before the I/O on 24/07/2026.

2. That the allegation made by the complainant—stating that my husband was present at Heituppokpi Youth Organisation (HYO) playground on **18th July 2026 at 7:30 A.M.** and assisted in dismantling/storing stolen fencing material—is **completely false, fabricated, and physically impossible**. My husband was **not present in Heirok or anywhere in Manipur** on 18th July 2026 and its subsequent following days. My husband departed from Imphal (IMF) for New Delhi (DEL) via **Air India Express Flight IX 1087 on 30th June 2026 at 17:50 hrs** (PNR: **B2S5JF**, Seat: 36E), and subsequently travelled onwards to Bengaluru. He has continuously remained outside the state of Manipur since 30th June 2026.
3. The complainant, Moirangthem Rajmani Singh, has intentionally, maliciously, and with full knowledge furnished false information to the police to implicate my husband fraudulently. This act was done solely to defame my husband, ruin his social reputation, and inflict mental harassment upon our family.
4. Fabricating evidence and giving false information to a public servant to injure another person is a punishable offense under Indian criminal law:
Section 217 BNS, 2023: Giving false information with intent to cause a public servant to use his lawful power to the injury of another person.
Section 228 BNS, 2023: Giving false evidence.
Section 229 BNS, 2023: Fabricating false evidence.
Section 356 BNS, 2023: Defamation.

PRAYER

In light of the documentary evidence provided herewith, it is humbly prayed that your good office may kindly:

1. Take on record the travel documents and Boarding Pass of Shri **Thokchom Basanta Singh** confirming his absence from the state on 18th July 2026.
2. Drop all police proceedings and remove the name of Shri **Thokchom Basanta Singh** from **FIR No. 18(7)2026 HRK-PS**.

3. Register a formal counter-complaint/FIR against **Moirangthem Rajmani Singh** under relevant provisions of the Bharatiya Nyaya Sanhita, 2023 for lodging a false, malicious, and fabricated report against my husband.

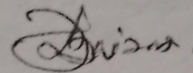

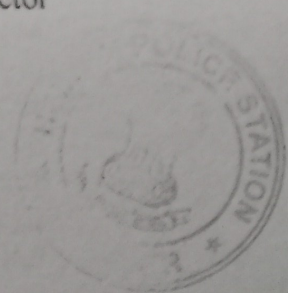

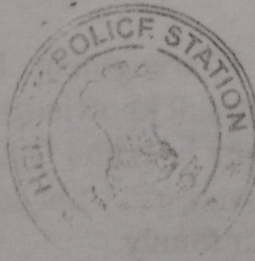
