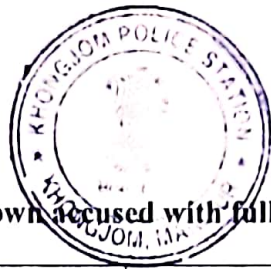

Sir,

I am to state that on 05/07/2026 at around 05.10 pm one Honda Activa 6G DLX, Rebel Red Metallic in colour bearing registration No. MN04H-0214, having Chassis No. ME4JK362FSW316580 and Engine No. JK36EW2314980, registered in the name of my self was found stolen by some unknown persons from the courtyard of the house of Naorem Iboyai Singh located at Tentha Khongbal, along with the original Registration Certificate (RC) issued by the DTO, Thoubal, which had been kept inside the vehicle's toolbox. While the vehicle had been parked at the said place, under proper lock and key and the same was untraceable in spite of vigorous search.
