Respected Sir,

I, the undersigned, have the honour to state the following few for perusal and prompt necessary action.

1. That, Keisham Bijaya Devi, wife of Suranjit Waikhom of Thoubal Kshetri Leikai, Thoubal District, Manipur - 795138, who is also my niece and a former employee of the HDFC Bank, Thoubal Branch without my knowledge and information had applied for a vehicle loan in my name as I am an account holder HDFC, Thoubal Branch and she knows the details of my account as I sometimes took her helped in depositing and withdrawing money.

2. That, after the loan was sanctioned and disbursed on 18.12.2021, she approached me to allow her to use the said vehicle (Model: Duster 1.3 RXZ Turbo PMT). She being my niece and considering our close relationship, I allowed her to use the said vehicle as per her wishes. As such she executed a declaration on 19.12.2021 affirming that she will pay the EMI for the said loan starting from 19.12.2021 to 19.12.2024 and finishing the complete payment of the EMIs on the next year i.e., 2026, in the presence of the witnesses.

3. That, later on I learnt that the said vehicle is being used and possessed by Soubam Seilash Singh, son of S. Anil Singh of Khurai Ningthoubung Leikai, Porompat Sub Division, Imphal East District, Manipur-795005 who was also a former employee of HDFC Bank and co-worker of my niece Bijaya Devi as agreed between himself and Keisham Bijaya Devi on the conditions that the EMIs will be paid by Soubam Seilash Singh.

4. That, thereafter two criminal cases were filed against me by HDFC before the Chief Judicial Magistrate, Agra in the year 2023 for bouncing of instalment made by Soubam Seilash Singh. The said criminal cases are still pending.

5. That, as such, approached Soubam Seilash Singh and Keisham Bijaya Devi to clear my name from the said two criminal cases and complete the payment of the EMIs in the year 2024. They also assured me that they will do the needful and complete the same within December 2024.

6. That, I being soft hearted women trusted their words and due to bad health I also cannot approach them frequently to know the status of the case and assurance given

by them. Suddenly I again received summons from the Chief Judicial Magistrate, Agra to appear before the said Court in the year 2025.

7. That, I have tried to approach them, but they are avoiding me and hiding from me. Having no alternative, I approached an Advocate to know the status of the case against me before the Chief Judicial Magistrate, Agra and came to know that one case is posted on 13.07.2026 and another is posted on 21.08.2026.

I therefore, request you to take appropriate action against the above name persons i.e., Keisham Bijaya Devi and Soubam Seilash Singh by enquiring them and also to take the said vehicle from their possession so that I can hand it over to the HDFC Bank so as to avoid jail time.

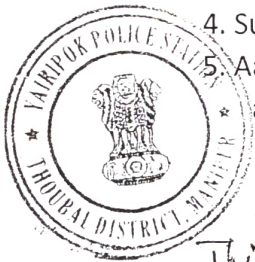

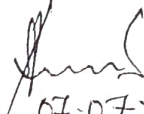
