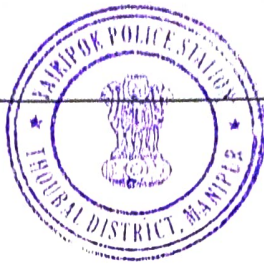

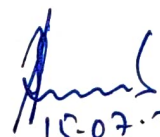

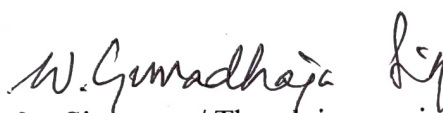

Subject :- Prayer for registration of FIR against accused persons namely (1) Gurumayum Rameshwor @ Mobi Sharma aged about 58 years and (2) Gurumayum Goswami Sharma aged about 52 years, both the accused persons are S/o (L) Gurumayum Mohon Sharma of Kakwa Lilando Lampak, P.O. & P.S. – Singjamei, District – Imphal East, Manipur, for offences of forgery, cheating, criminal breach of trust, impersonation and illegal sale of religious trust property of Hindu deity Gourachandra installed by the local people of Ningomthong Sairom Leirak.

Respected Sir,

I, the undersigned Complainant is the Secretary of the Gourachandra Shebait Jaganatha Marup/ Committee of Ningomthong Sairom Leirak, humbly submit this complaint application seeking immediate registration of an FIR and necessary legal action against the accused persons named herein.

Facts of the Case :

1. That, firstly in the Jamabandi record, the said agricultural land was recorded in the name of Gourachandra Shebait, (i) Ningthoujam Bapu Singh, (ii) Meisnam Khema Singh, (iii) Kondum Kheban Singh, (iv) Thokchom Irabanta Singh of Ningomthongjao lying under Patta No. 185 (Old), 173 (New), covered by C.S. Dag No.1082 of measuring an area of 1.0535 Hectares, situated at village No.99- Charangpat, District – Thoubal, Manipur, is a sacred religious property dedicated to the said Hindu deity Gourachandra since 1962 by the local residents of Ningomthong Sairom Leirak.
2. That the said agricultural property is managed and protected by the Gourachandra Shebait Committee from 1962, and no individual has any exclusive right to alienate or transfer the same.
3. That it has recently come to the knowledge of Gourachandra Shebait Committee that :
 - (1). Gurumayum Rameshwor @ Mobi Sharma (Shebait), and
 - (2). Gurumayum Goswami Sharma (Shebait),

have fraudulently and clandestinely sold out half portion from the total a agricultural land measuring an areas of 1.0535 Hectare, without any authority, consent, or knowledge of the said Gourachandra deity Shebait Committee on 7th April 2025

(3). That the accused persons, in furtherance of their criminal conspiracy, have

(a) Prepared a forged and fabricated documents, including a fake letterhead in the name of **"SHRI SHRI GOURACHANDRA DEBATA, Ningomthong Sairom Leirak"**.

(b) Impersonated office bearers of a non-existent/ fake committee, by falsely representing that:

- Shri Gurumayum Rameshwor @ Mobi Sharma acted as "President" under the false name "Gurumayum Bobi Sharma" and

Shri Gurumayum Goswami Sharma acted as "Secretary" of the said fake Committee.

(C) the said two accused persons, in furtherance of their criminal conspiracy and with a dishonest intention to grab and illegal sell the said temple property of agricultural land, had fraudulently obtained the signature of the then Pradhan of Thongju Part-1 Gram Panchayat, Imphal East, namely Yengkhom Thoibi, on blank paper.

That the said blank paper signed was subsequently misused by the accused persons by preparing fabricated and fake letterhead/ document in order to give an appearance of legitimacy and authority to their illegal acts of selling the agricultural land belonging to the said Gourachandra deity.

According to the Hindu Law, a Shebait has no right to alienate or transaction or sale any debutter property which are belongs to the deity.

Nature of Offences:

4. That the above acts of the accused persons constitute cognizable offences punishable under the provisions of the Bharatiya Nyaya Sanhita, 2023(BNS), including but not limited to:

Cheating and dishonestly inducing delivery of property;

Criminal breach of trust;

Forgery for the purpose of cheating,

Using forged documents as genuine;

Impersonation and falsification of records



- Criminal conspiracy.

(Equivalent to erstwhile IPC Sections 406, 409, 420, 465, 468, 471, 120 B IPC)

5. That the said fraudulent transaction was carried out secretly and came to light only recently upon verification of revenue records and internal inquiry by the said deity Committee of the Gourachandra Devta.

6. That I am enclosing herewith the following relevant documents :

1. Certified true copies of Jamabandhi records showing the said agricultural land in the name of Gourachandra Shebait of Ningomthongjao;
2. Copies of forged/ fake letterhead and documents prepared by the present two accused persons;
3. Any other supporting material of videos recording which are relevant to this complaint Case.

In view of the above facts and circumstances, it is most humbly prayed that your good office may kindly :

- a) Register an FIR Case against the accused persons Gurumayum Rameshwor @ Mobi Sharma and Gurumayum Goswami Sharma under appropriate provisions of law;
- b) Conduct a fair and thorough investigation into the matter;
- c) Take immediate steps to prevent further illegal sale or alienation of the said agricultural land remaining portion;
- d) Initiate necessary action for cancellation of the fraudulent transactions;
- e) Take all necessary legal steps to protect and restore the property of the Gourachandra deity.

I and the said committee members are assure full co-operation in the investigation and shall provide any further information/ documents as required.

This act has deeply hurt the religious sentiments of the local community and involves serious misuse of religious trust property, hence requires urgent intervention.

Kindly treat this matter as urgent and serious.
