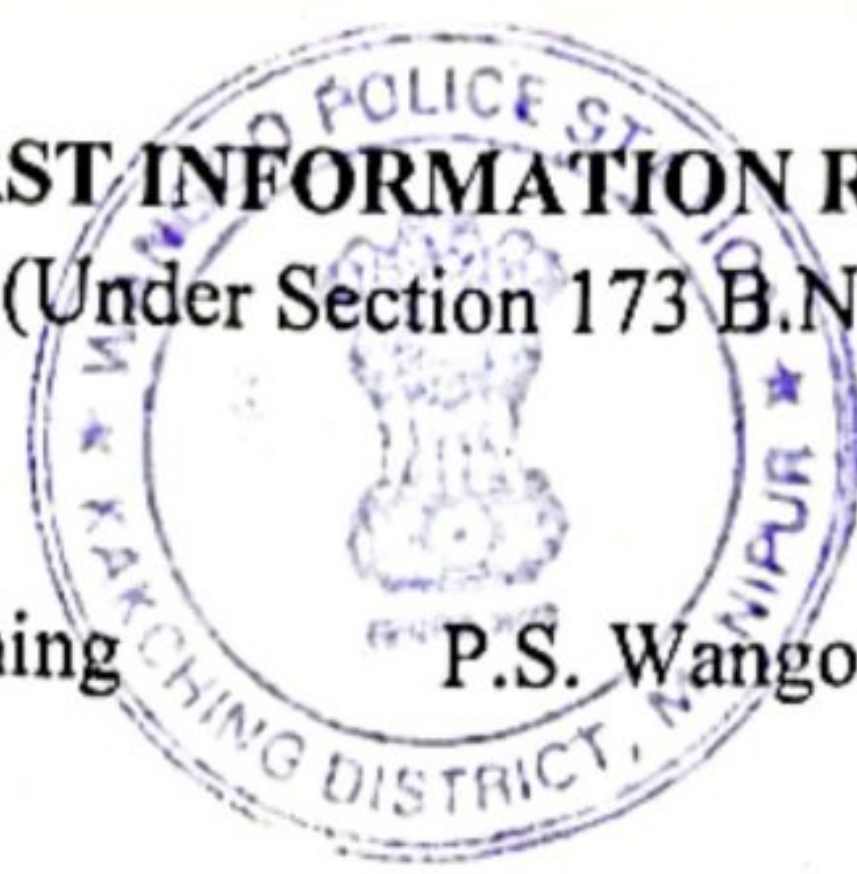

Sir,

I have the honour to report that today, i.e., 20/06/2026, at about 1100 hrs, a specific and credible intelligence input was received regarding the presence and movement of an active cadre of the proscribed unlawful organization KYKL (Kanglei Yawol Kanna Lup) at Wangoo Mamang Sabal area and his involvement in organizational activities including collection of extortion money on behalf of the said organization. Acting upon the said information, a column of 43 AR, rushed to the area and conducted a search operation at the suspected location in Wangoo Mamang Sabal area.

During the operation, one suspected individual was detained from Wangoo Mamang Sabal near the brick field of Naocha. On preliminary examination, he identified himself as Pukhrambam Kiran Singh (34 years), S/o P. Ibocha Singh of Langathel Maning Leikai, Thoubal District, presently residing at Wangoo Mamang Sabal.

During sustained questioning, the detained person voluntarily disclosed that he is an active cadre of the proscribed organization KYKL. He further disclosed that he joined the said organization in the year 2007 under Army No. 407 of the 24th Batch and underwent 40 (forty) days basic military training in Myanmar (Burma). He further revealed that he was earlier arrested by Imphal West CDO in connection with his association with the said organization in the year 2018 and was subsequently released on bail after about seven months of judicial custody.

The individual further disclosed that despite his previous arrest, he again rejoined the same organization in the year 2023 through one S/S Finance Secretary Gandhi of KYKL and has since been functioning under the command of one S/S Major Luckyson of the organization.

During further questioning, he disclosed that he was involved in collection of extortion money and issuing monetary demands on behalf of the organization from various individuals, government employees, educational institutions and other establishments in and around Kakching District for raising funds and supporting the activities of the proscribed organization. Based on his disclosure and available evidence, he was arrested from the brick field of Naocha Located at Wangoo Sabal at about 1345 hrs. after observing all legal formalities.

Thereafter, the arrested person was handed over to the Officer-in-Charge, Wangoo Police Station, for registration of a case and further necessary legal action.

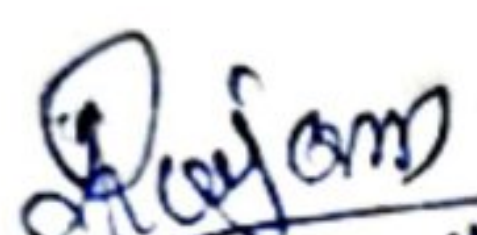
