First Information contents: On 06/07/2026 at 1700 hrs a convoy of 40 Assam Rifles consisting of 01 Officer, 1 JCO and 16 other ranks in 2 X TATA 1212 and 1X Light Vehicle (THAR) was returning from HQ 10 Sector Assam Rifles, Sonasui for Battalion HQ, Shangshak, at about 300meters short of Nungshang Hong Bridge, the convoy was attacked by anti-national elements with explosives and heavy firing from dominating heights. In the attack, 02 personnel of 40 sustained fatal injuries, namely (1) G/57311 WO (OD) Balwant Singh, 40 AR and (2) G/23017 HAV (GD) Chandra Mohan Singh, 40 AR. The casualties were evacuated to Unit Hospital Shangshak. Hence a case has been registered on FIR No. 7(7)2026/UKL-PS 103/113/324/3(5) BNS, 16/18/20 UA(P) Act. & 25(1-C)A Act. and endorsed to Wungkhaning MPS, SDPO/UKL for investigation.

FIRST INFORMATION REPORT

1. On 06 Jul 2026, at 0710hrs, a column strength comprising 01 Officer, 01 JCOs and 16 other ranks in 02 x TATA 1212 and 01 x Light Vehicle (Thar) moved from Battalion Headquarter, Shangshak to HQ 10 Sector Assam Rifles, Somsai. After completing the assigned task, the column commenced its return journey from Sector Headquarters, Somsai at 1230hrs. While enroute at approximately 1340hrs, about 300 meters short of Nungshang Bridge, the convoy was attacked by Anti National Elements employing explosives and heavy firing from the adjacent dominating heights..
2. The column reacted immediately with heavy volume of retaliatory fire and engaged the Anti National Elements. Additional reinforcement columns also reached the incident site and carried out retaliatory fire, the firefight stopped at around 1610hrs and the casualties were evacuated to unit hospital Shangshak.
3. During the attacked by Anti National Elements the following personnels of 40 Assam Rifles sustained fatal injuries. Details are as under:-
 - 3.1. G/57311 WO (GD) Balwant Singh, 40 Assam Rifles.
 - 3.2. G/2301707 Hav (GD) Chandra Mohan Singh, 40 Assam Rifles.
4. In view of the above, it is requested that an FIR be lodged against the assault on security forces personnel and the anti national activities. It is also requested that a copy of the FIR be handed over to the unit for our records please.
