Ajay Singh of Thoubal Awang Leikai minor daughter namely aged about 13 years and 4 months who is reading in class vii at Elite Foundation Kangleipak, Thoubal Tomjing was disappeared from her home. At the time of her disappearance, her parents believed that she might be went to attend tuition class as usual at the residence of tutor Leishangthem Baby Devi located at Thoubal Awang Leikai. However, she failed to return home till late in the evening. Upon enquiry at the tuition centre, it was learnt that her daughter did not attend tuition class on that day. Subsequently, family members conducted extensive search across all possible places and among relatives and acquaintances, but her whereabouts could not be ascertained. Considering the age of the missing girl, her unexplained disappearance and the fact that she did not reach her tuition centre, there are reasonable grounds to suspect that the said minor daughter might have been kidnapped or abducted by unknown person(s) and wrongfully concealed at unknown place. Hence the case. On 09/06/2026, 1(one) person namely Malemnganba Konsam aged about 20 years S/o K. Bimolchand Singh of Khagempali Huidrom Leikai, Imphal was arrested and Further, on 17/06/2026, 1(one) formal arrested namely Leimapokpam Lemba @ Chalamba (24) yrs S/o (L) L. Nokulchandra Singh received a reliable information that some stolen vehicles were about to deliver at Lilong Loumanga near waiting shed by some vehicle lifters. Without any further delay, teams of Lilong PS led by Inspt. N. Subash Singh, OC/LIL-PS under the supervision of Shri Manoj Prabhakar M, IPS, Superintendent of Police, Thoubal rushed to Lilong Loumanga near waiting shed. Acting on the information, a joint team of Commando Unit Thoubal led by Inspt. K. Nitaranjan Singh OC, CDO Unit/Thoubal under the supervision of Shri Hijam Devendra Singh, MPS, Addl. SP(Ops)/Thoubal and under the overall supervision of SP/Thoubal along with civil team and a column of 31 AR immediately rushed to the said area at around 05:25 pm.
