Date and time of incident: 24/04/2026 at around 6 AM to 9 AM. 2. Place of incident: Mullam village 3. Brief facts: On the above date, unknown Tangkhul miscreant attacked Mullam village. They burnt down and household property were destroyed by fire. The attack caused widespread damage to the village. I was force to flee and have been displaced since then. 4. Details of accused: Unknown Tangkhul Miscreant 5. Cause of delay: Due to travelling difficulty 6. Property lost/ damaged: My residential house and household belonging were completely burnt. Estimated loss of property worth Rs.16,14,000/-lakhs. Details of lost items are attached. 7. Witness: Other villagers of mullam village who were also victims of the attack.

Since Mullam village does not fall under your jurisdiction, I request you to kindly register this complaint as Zero FIR for offense of rioting, mischief by fire, criminal intimidation etc. and transfer to the concerned police station having jurisdiction near Mullam village for further investigation.
