With due regards, I have the honour to submit a report that an operation of poppy destruction was launched today i.e 08/02/2026 at @0600 hrs by a combined security forces comprising Kangpokpi District Police led by Shri Syed Samir Ahamad, MPS, ASP (Ops) and his escort party, Shri Thaingampao, SDPO-NKM and his escort party, Shri Abash Khan, OC-NKM, a team of Kangchup PS, 1 column (1-10) of 19 Assam Rifles, 1 platoon of B-30 Bn CRPF and 1 platoon of D-30 Bn CRPF, under the guidance and supervision of Shri Abhinav, IPS, SP-KPI.

During the operation, areas with poppy cultivation were detected at Awlmun, Songlung and Lhangjol. All illegal poppy plants were destroyed by the combined forces. The total area of poppy cultivation is approximately 27 acres. (Awlmun- 15 acres, Songlung 5 acres, Lhangjol- 7 acres). During the operation, 5-farmhuts amidst the poppy cultivation were burnt down, 5- fertilizer bags and 3 salt bag sacks destroyed. One kenbo bike hidden near the poppy field was found and seized. No any individual who is involved and claimed to be the owner of the illegal poppy plantation was found during the operation. The operation of poppy destruction was concluded at 1410 hrs.

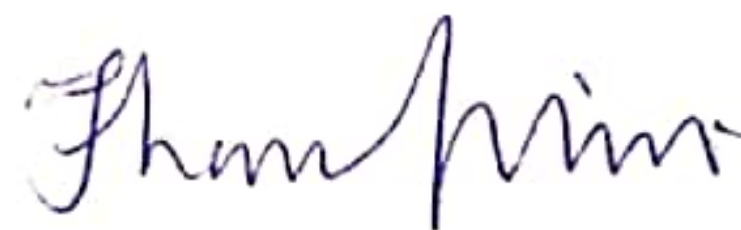
