I, have the honour to report that today, 11/08/2026 at about 04:30 pm, reliable information was received through own sources regarding the presence of an active cadre of the banned organization PLA/RPF Waikhong Uyong khunou area, Kakching District.

Acting on the said information, a combined team of CDO Unit, Kakching, comprising Kilo-30, Kilo-74 and Kilo-76, along with Lady CDO, led by Subedar Ksh. Prakash Singh and a column of 46 Assam Rifle, under the command of Subedar Yengkhom Shaktishen Singh, OC/CDO Kakching, under the supervision of Shri Amarjit Singh Lamabam, MPS, Addl. SP (Ops), Kakching, and under the overall supervision of Smt. Priyadarshini Laishram, IPS, Superintendent of Police, Kakching, immediately proceeded to the suspected location and conducted a cordon and search operation in the suspected area. During the operation, one suspected individual was detained from a residential house at Waikhong Ningthou Manai Uyong khunou.

During preliminary interrogation, the detainee identified himself as Sanasam Amumcha Singh @ Solomon (46) yrs. S/o. Sanasam Dhojo Singh of Waikhong Ningthou Manai, Kakching District. Upon sustained questioning he admitted that he is an active cadre of the banned organization PLA/RPF. He had joined the organization in 2008 through one S/S Corporal Gautam, under Army No.3015 holding the rank of Lance Corporal of the said banned organization. He further revealed that earlier he was arrested by CDO-Moreh in 2013. After being released from bail, he rejoined the same organization in 2023 through one S/S Lt. Colonel Open and he has been working under the command of Lt. Colonel Ronel divisional commander of Kakching. He disclosed that he has been regularly sending report of illegal activities of the banned organization to said Lt. Colonel Ronel divisional commander of Kakching for every month and also revealed that he was paid Rs-14,700 (fourteen thousand seven hundred) every month as a honorarium. Based on his disclosure and the available incriminating evidence, he was arrested at the spot at 05:50 pm after observing all legal formalities.

From his possession recovered one Realme C30 bearing IMEI1- 962873062394579/49 & IMEI2- 862873062394561/49 along with Airtel SIM card no. 9612012938 was seized at the spot at 05:57 pm by observing all legal formalities and videography of the seizure was carried out at the spot.

Thereafter, the arrested individual along with the seized articles, arrest intimation, grounds of arrest were handed over to you, for further necessary legal action.
