Today, i.e. 31/3/2026, on receipt of credible information regarding illegal activities being carried out through a WhatsApp group named "Thal order na", involving buying and selling of arms and ammunition, necessary verification was conducted.

During the course of enquiry, one individual, namely Leningou Khongsai s/o Paothang Khongsai of Motbung Luikhuh Veng, who was found to be a member of the said WhatsApp group, was brought from Motbung for examination. Upon questioning, he stated that he had been added to the said WhatsApp group without his knowledge and consent, remained inactive, and was subsequently removed from the group after a short period.

Based on his statement and further enquiry, it was revealed that the said WhatsApp group was created and administered by one Boymin Khongsai, resident of Lhungjang Village, Saikul.

Acting upon this information, a police team conducted an operation and apprehended the said WhatsApp group admin from his residence at Lhungjang Village, Saikul for verification and brought to G-SPM-PS.

Preliminary investigation revealed that the accused person identified as Seiminchung @ Boymin Khongsai(19) s/o Lunminthang Khongsai of Lhungjang Village, Kangpokpi District, along with other unknown members, was actively involved in circulating messages, photographs of various weapons and its prices and other digital content relating to illegal procurement and sale of Arms and Ammunition through the said WhatsApp group and possibly other social media platforms.

The above acts of the accused person(s) prima facie constitute offences of illegal dealing in arms, criminal conspiracy, and misuse of electronic platforms for unlawful activities.

Hence, a case under FIR No. 19(3)2026 G-SPM-PS u/s 61 BNS & 25(1)(a)/1AA/1B(c) Arms Act has been registered for investigation and the said accused is arrested in connection with the case.
