Madam,

I have the honour to report you that on 20/07/2026 at night in between 10:00 p.m, to 11:00 p.m, while I was sleeping alone on my bed, my father -in -law namely Haobijam Modhu Meitei (65) S/o. Late H. Yaima Meitei of Karang Maning Leikai and my brother- in- law namely Oinam Tomba Singh S./o. O. Apabi Singh of Laphupat Tera A/P Karang Maning Leikai entered my bedroom taking undue advantages of loneliness when all members of the family went for watching T.V at our neighbour's house. My father- in-law threatened to kill me by putting a knife on my neck. Out of fear, I was not able to shout but when I tried to shout my brother- in- law covered my mouth with his hands. Firstly my father- in -law raped me followed by my brother- in- law. They threatened me to kill if I disclosed about the matter to anybody. Again on 24/07/2026 at around 10:00 p.m, both of them entered my bedroom while I sleeping alone on my bed, and raped me by committing the same act.

I could not report well in time due to lack of legal knowledge.

I therefore requested your goodself to kindly take up necessary legal action against the above noted persons.
