13. First Information contents:

The brief fact of the case is that on 23rd March, 2026 at around 1:30 am to 2:00 am while reaching in between Keithelmanbi and Sapermeina, some unknown young men in civic wearing Burma hunting boot and demanded Rs. 5000/- (Five Thousand) using gun language as he does not speak either or English. The complainant offered the unknown young man Rs. 350/- the only money he had with him but the unknown young man demanded for Rs. 5,000/-. They (the unknown young man) threatened them to be taken to their camp if their demand is not met. The complainant requested to consider for payment through Gpay of my friend back home and even requested for payment while coming back from Imphal but they denied and continued to stick to their demand. They informed that the person who took us from the highway was a sergeant major. Besides, that their identity could not be ascertained. They were searched, harassed, punched and taking away the mobile phone Realme containing Airtel SIM card- 9612252539 along with Rs. 350/- (belonging to Kesinlo Kath).

Hence, a case under FIR No. 12(5)2026 KPI-PS u/s 131/115(1)/126(2)/308(2)/3(5) BNS has been registered for investigation.

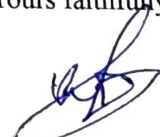
Sir,

With due respect, we the undersigned persons have the honour to lodge a complaint regarding the incident that occurred on 23rd March, 2026 at around 1.30 AM to 2.00 AM between Keithelmanbi and Sapermeina under Kangkokpi District of Manipur State.

That Sir, we are unemployed youth from Phenda village, Tseminyu district living out from small business. In this regard, we usually collect Yongchak (Tree bean/stink bean) from Tseminyu District, Nagaland to sell it in Imphal, Manipur every now and then. On the 22nd of March, 2026, we took our products from Tseminyu at around 10.00 PM(Night) and started for Imphal on a hired vehicle (EECO VAN) bearing registration Number-AS05W-1235. At around 1.30 AM to 2.00 AM between Keithelmanbi and Sapermeina under Kangkokpi District before reaching Imphal, we were stopped in the middle of road by a young man in civics wearing Burma hunting boot and demanded Rs. 5000/- (Five Thousand) using sign language as he does not speak either or English. We offered him Rs. 350, the only money we had with us but he demanded for Rs.5000/- and ordered us to follow him and we were taken up to a church like place where we interrogated in a dark room by two person, one of whom speak Hindi and demanded Rs.5000/-. They threatened us to be taken to their camp if their demand is not met. We requested to consider for payment through Gpay of my friend back home and even requested for payment while coming back from Imphal but that also was denied and continued to stick to his demand. We were informed that the person who took us from the highway was a sergeant major. Besides, that, their identity could not be ascertained. We were searched, harassed and punched and at last sent back but not before taking away our mobile phone (belonging to Kesinlo kath) -Realme with Airtel SIM card-9612252539 along with Rs. 350 which was with us.

That Sir, we are resident of Tseminyu Town under Tseminyu Police station. Therefore, we request your authority to kindly register this complaint as a Zero FIR and transfer it to the concern Police station for necessary action please. Your kind consideration to our application will be highly appreciated.
