I have the honour to report that based on an input regarding a jungle fire at Waphong on 20.02.2026, which caused damage to many valuable plants, SI Abdul Kalam along with his party rushed to the spot to enquire into the matter.

Based on the enquiry report, it was learnt that about 500 numbers of Orange plants, 700 numbers of Lemon plants, 2,500 numbers of Banana plants, and about 1,500 numbers of trees including Wang, Tolhao, and Leihao planted at Ukukwang hill in Waphong Intham were found damaged and burnt by the fire.

The incident occurred on 20.02.2026 and is suspected to have been set ablaze by unknown miscreants at around 06.30 a.m.

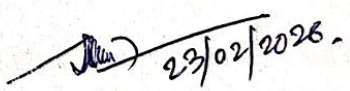
