13. First Information contents:

The brief fact of the case is that on 10/6/2026 at 2140 hrs, acting on reliable input regarding drug trafficking along NH-2, OC-KPI team and NDO team led by self, supervised by SDPO/Kangpokpi and under the overall instructions of SP/Kangpokpi, intercepted two vehicles near the Waterfall area, approximately 2 km north of KPI-PS. The intercepted vehicles were (1) Winger B/R. No. MN-03B-0283 driven by Md. Zamir Khan (45) yrs S/o Md. Abdullah of Lilong Haoreibi Makha Leikai, PS-Lilong, Thoubal District, Manipur along with one occupant namely Samim (36) yrs W/o Md. Jamir Khan of Lilong Haoreibi Makha Leikai, PS-Lilong, Thoubal District, Manipur and (2) Nissan Magnite Car B/R. No. MN-08A-0877 driven by Md. Juma Khan (42) yrs S/o (L) Md. Taher Ali of Kshetai Makha Leikai, PS-Porompat, Imphal-east who is working in Manipur Police Department and presently posted at Maram-PS and attached to Hengbung-OP, and one occupant namely Md. Haifizuddin (42) yrs S/o Safiullah of Golapati, PS-Porompat, Imphal-East, Manipur who is working in Manipur Police Department and presently posted at T Khullen Nakka Check Post as Special Operation Team (SOT), Senapati District. The above two police personnel were dressed in full-uniform at the time of detaining at the spot.

On preliminary questioning of the four individuals separately, Md Zamir Khan disclosed that on 10/6/2026 at @ 7: 00 am he was stopped at T Khullen Nakka Check Post by the police for checking his vehicle mentioned above. While checking his vehicle (Winger), police have found drugs that he had concealed in the vehicle. The police team took him inside their room for negotiation and demanded Rs 5 (five) Lakhs for the safe release/passes and after sometime, settled for Rs 4 (four) lakhs. As such, Md. Zamir Khan had informed his wife namely Samim (36) yrs W/o Md. Jamir Khan of Lilong Haoreibi Makha Leikai, PS-Lilong, Thoubal District, Manipur about the matter and told her to arrange Rs 4 (four) lakhs and bring at T. Khullen Police Check Post as soon as possible. Accordingly, Samim affords to arrange Rs 2 (two) lakhs only and rushed toward T. Khullen Police Check Post to rescue her husband Md. Zamir Khan. On arrival at T. Khullen, due to shortage of the previous settled amount of Rs 4 (four) lakh,

the police team denied to receive Rs 2 (two) Lakh. However, after prolong negotiation between them; they finally settled the matter on the condition that the remaining amount of Rs 2 (two) lakhs will be paid at the residence of Md. Zamir Khan at Lilong. To collect the said amount, the two police personnel (mentioned above) were detailed among them to accompany Md. Zamir Khan and his wife (Samim) toward Lilong from T. Khullen Police Check Post. On reaching near Water Fall area, they were intercepted by Kangpokpi Police teams as per source report. The statement of Samim also corroborated with the above statement and she further disclosed that she was called inside the police room where 5/6 polices awaited her. As per the direction of one police (later known as the above detained Md. Haifizuddin), she opened the drawer of one table placed in the room and kept inside the drawer.

On knowing the presence of drugs inside the vehicle, I have informed one Executive Magistrate, Kangpokpi HQ and requested his presence at the spot to witness necessary legal formalities. On arrival of Magistrate at the spot, due to inconveniences of performing legal formalities at the spot as it was late night and also the prevailing law and order situation being deteriorated, shifted the location to Kangpokpi-PS campus with the permission of E/Magistrate.

As per the instruction of Executive Magistrate, driver of Winger (Zamir Khan) among the detained persons have taken out the five packages suspected to be containing WY tablet one by one which were concealed inside the empty space of the two front head light of Winger B/R. No. MN 03B 0283. The packages were marked A, B, C, D and E for identification. On being weighed, A weighs 1.194 kgs; B weighs 1.184 kgs; C weighs 1.186 kgs; D weighs 1.186 kgs and E weighs 1.176 kgs respectively including the weight of their plastic packets. All the packages marked A-E were kept inside one transparent polythene bag and on being weighed, it is found weighing 6.60 kgs including the weight of plastic packets.

On completion of all the formalities, the five packages were seized in the presence of the Executive Magistrate-Kangpokpi HQ, detained persons and witnesses by obtaining their respective signatures at 12:20 am and the four detained individuals were arrested at 12:25 am on the same day (11/6/2026).
