13. First Information contents:

The brief fact of the case is that today i.e. 23/06/2026 at 10:30 am, this Police Station received a copy of the order dated: 22/06/2026 issued by the Committee on Tribal Unity (COTU), Sadar Hills, Kangpokpi District, titled "WITHDRAWAL OF NH-2 & NH-37 BLOCKADE", wherein CoTU announced the withdrawal of the emergency blockade imposed on NH-2 and NH-37 with effect from 21/06/2026, subject to certain terms and conditions relating to Security responsibility, Liability for Security Lapses, Movement of Essential Commodities and Justice for Victims after the sole responsibility was owned and ensured by Superintendent of Police, Kangpokpi.

Preliminary verification reveals that no such terms and conditions were officially issued or approved by the Superintendent of Police, Kangpokpi and no such meeting, agreement, or executive understanding took place, nor has the Office of the Superintendent of Police given any such commitments, assurances, or undertaken any separate responsibilities outside of statutory law enforcement mandates. The publication and dissemination of such allegations appeared to be false and misleading and were likely to created confusion among the public, tarnish the reputation of public authorities, provoke public disorder, and adversely affected public peace and tranquility. The publication bears the stamp of the "MEDIA CELL, Committee on Tribal Unity (CoTU)" and reflects a premeditated, coordinated conspiracy hatched by multiple individuals within the organization to systematically draft, seal and broadcast this false and threatening order to undermine the lawful authority of the state. It was highly suspected that the accused persons have willfully created a forged and false administrative record/order, falsely binding the highest police authority of the district to unauthorized terms.

Hence, a Suo-Motu case under FIR No. 14(6)2026 KPI-PS u/s 336(2)/340/353/351/308/61 BNS has been registered for investigation.
