13. First Information contents:

The brief fact of the case is that on 26/6/2026 at 8:30 pm, as per information received from Cyber Cell, Kangpokpi, it has come to notice that a Facebook account namely "Proud Indian @ Dynasty Dounge!" has published and circulated a social media post containing series of serious allegations against Shri Rahul Gupta, IPS, Superintendent of Police, Kangpokpi by attaching his photograph on the page share via link <https://x.com/i/status/2060755171991499246> and <https://x.com/i/status/2069067709409857629>.

Firstly, the post alleges that Kharam Vaiphei Village was attacked and set on fire by cadres of NSCN (IM) and ZUF (Kamson Group), and further alleges that prior to the incident the Indian Army Gorkha Rifles and the Central Reserve Police Force directed village volunteers to vacate their defensive positions on the assurance that the security forces would protect the village. It is further alleged that after the withdrawal of the said village volunteers, members of NSCN (IM) and ZUF carried out the attack and arson. The post additionally claims that a media outlet associated with NSCN (IM), namely "KHANUITHOT-KHON", publicly appreciated the Superintendent of Police, Kangpokpi, for his alleged role in the incident. Based on these allegations, the Facebook account has appealed to the Hon'ble Union Home Minister to take action against the Superintendent of Police while displaying his photograph and portraying him as having facilitated the attack.

Secondly, it has come to notice another post published and circulated in a social media by the same account holder alleging the failure on the part of Shri Rahul Gupta IPS, Superintendent of Police, Kangpokpi for his accountability, administration and impartial governance toward the people of Kangpokpi and also further imposed some arbitrarily direction on him stating that he must be transferred immediately from Kangpokpi to Imphal-East or must be stationed in his district, to immediately return all the seized guns from the villagers of Leilon village and to stop harassment of the villagers.

On preliminary examination vide GD Entry No. 30/KPI-PS/2026 Dated: 26/06/2026, the X account holder was found to be James Dounge! contact number #9612848986. The contents of the publication appear to contain grave and unverified allegations against a senior public servant without any supporting material. All these allegations are prima facie false, fabricated, and deliberately circulated through social media with the intention of creating public disorder, undermining confidence in law enforcement, defamation/injury to reputation or provoking hostility against the Superintendent of Police. The publication has the potential to create distrust against the police administration, incite public disorder, disturb public tranquility, and adversely affect the maintenance of law and order in the district. The administrator(s), author(s), publisher(s), and all other persons found involved who have made the allegations after knowingly false and intentionally circulated to provoke public unrest and hatred against the district police administration constitute cognizable offences.

Hence, a Suo-Motu case under FIR No. 16(6)2026 KPI-PS U/S 353(2)/356/196 BNS has been registered for investigation.
