"Justice for NagaTangkhul civilians" and "Ours plan success. Thanks Kangpokpi District Superintendent of Police for helping Our's Naga Villagers" the post observed by taking screenshot.

On preliminary verification with the office of Superintendent of Police Kangpokpi District, and the available records, no material was found to support the allegations that the Superintendent of Police Kangpokpi District has extended any such assistance, support, or commitment as alleged in the posts. The content of the posts are therefore, prima facie found to be false and misleading.

The publication and dissemination of such allegation through a public WhatsApp channel appear to have been made with the intention, or likely, to mislead the public, harm the reputation of the Superintendent of Police Kangpokpi District, and disturb public tranquility in the District. The identity of the administrators/operators Superintendent of Police Kangpokpi District responsible for publishing the posts is presently unknown.

Hence, Suo-Motu case under FIR No 20(7)2026 KPI-PS u/s 356/353(2)/61(2)/3(5) BNS has been registered against the unknown administrators/operators of the said channel.
