13. First Information contents:

The brief fact of the case is that on 02/07/2026 one Mr. M. James Thadou, recently filed a formal complaint/petition seeking security for Mr. Sehkhonthang Sitlhou, Chief of Lhungjang. In the text of the said complaint, the accused namely (Mr. M. James Thadou) made completely baseless, false, and malicious allegations. He (accused) falsely claimed that Mr. Sehkhonthang Sitlhou received active threats from "Jangboi Kipgen of KNF" and the "Commandant of KRA." Crucially, Accused intentionally dragged the Complainant's (Thangminlen Kipgen) name into the matter. He falsely alleged that a formal "summon" was served to Mr. Sehkhonthang Sitlhou by the Complainant in his capacity as the President of Kuki Inpi Sadar Hills on 3rd July, 2026. The Complainant has absolutely no link, connection, or involvement with the aforementioned individuals or the matter. The accusation is a completely fabricated and concocted story set up by the Accused to mislead authorities. Demonstrating the falsity of the claim, Mr. Sehkhonthang Sithlou Chief of the Lhungjang himself issued a public clarification on 5th July, 2026, completely refuting these allegations. The allegations made by Mr. M. James Thadou against the Complainant are entirely imaginary and driven by malice. No such summon was ever issued or served by the Complainant. The Accused knowingly published these false claims to paint the Complainant as an associate or facilitator of unlawful activities and armed threats. These reckless statements have severely tarnished the Complainant's public image, lowered his reputation in the estimation of right-thinking members of society and caused him immense mental agony. This deliberate act directly harms the Complainant's lifelong social work, career and standing within the Kuki Inpi Sadar Hills, as well as his general public standing.

Hence, a case under FIR No. 22(7)2026 KPI-PS u/s 356/353/61/217 BNS has been registered for investigation into the matter.

Details of the Accused

Mr. M. James Thadou, Self-styled President, Thadou Inpi, Manipur.

Background of the Complainant

The Complainant is a highly respected citizen, a dedicated social worker, and the democratically elected President of the Kuki Inpi Sadar Hills. He commands high regard, impeccable integrity, and an unblemished reputation among the general public and the community.

Facts and Nature of the Offence

- It has come to the knowledge of the Complainant that the Accused, Mr. M. James Thadou, recently filed a formal complaint/petition seeking security for one Mr. Sehkhonthang Sitlhou, Chief of Lhungjang. In the text of the said complaint, the Accused made completely baseless, false, and malicious allegations.
- The Accused falsely claimed that Mr. Sehkhonthang Sitlhou received active threats from "Jangboi Kipgen of KNF" and the "Commandant of KRA."

2. Initiate an immediate investigation into the matter to secure justice and prevent further damage to the Complainant's reputation.
