The brief fact of the case is that on 20.07.2026 at 7:15 pm, reliable information was received that on the same day at around 6:50 pm, some unknown armed miscreants had allegedly fired two rounds from firearms at a location situated between Phyaphou Village and L. Songtun Village, approximately one kilometer south of Kangpokpi Police Station. It was further learnt that the same unknown miscreants again fired one more round at around 7:00 pm at the same location. The repeated firing of firearms in a general populated area created panic, fear and unrest among the local inhabitants, thereby disturbing public peace and tranquility and posing a serious threat to the safety and security of the civilian population. On preliminary enquiry, no report of any casualty, injury or damage to property has been received so far. The identity of the offenders and the motive behind the incident are not yet known. The above incident discloses the commission of cognizable offences by unknown armed miscreants endangering human life, disturbing public peace and criminal intimidation to the general public.
