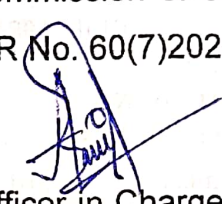


12. First Information contents:

Today, i.e., 30/07/2026, at 3:00 pm received an information at 2:55 PM, regarding a press briefing video chaired by one Yumkhaibam Manoj, a candidate of All Manipur MSPCL & MSPDCL 2019 Exam Completed stating that they had announced a 24-hour statewide Manipur Bandh commencing from 12:00 AM on 01/08/2026. The committee has circulated written appeals requesting various organisations, including Ema Keithel, to extend support to the proposed bandh.

Source information further indicates that the proposed bandh is intended to disrupt normal public life, including transportation, commercial activities, business establishments, educational institutions, government and private offices, and other essential services. There is a reasonable apprehension that persons supporting the bandh may compel members of the public to close their shops and business establishments, suspend commercial activities, stop vehicular movement, and interfere with the lawful activities of the public, thereby causing obstruction, intimidation and disturbance to public order.

As the information prima facie discloses the commission of cognizable offences, a suo motu case has been registered vide FIR No. 60(7)2026 City-PS u/s 353(2)/351(2)/62 BNS for investigation.

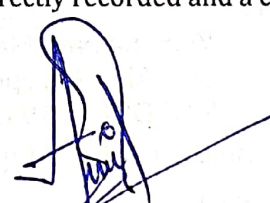
