Subject:- Request for Review and Preservation of CCTV Footage Regarding a
Road Traffic Accident at Keishampat Junction.

Respected Sir,

I respectfully submit this application to request your kind assistance in reviewing and preserving the CCTV surveillance footage relating to a road traffic accident that occurred at approximately 4:30 PM of 1/08/2026 at Keishampat Junction.

At around 4:30 PM, I was travelling on a TVS Jupiter scooter along with a female passenger from the Pishum Road side. When the traffic signal turned green, we proceeded to cross the Keishampat junction, Imphal. While we were halfway through the intersection, a rider on a red scooty, coming from the Kwakeithel side, allegedly violated the red traffic signal and collided with our scooter.

Due to the impact, both of us were thrown onto the road. The female passenger sustained a head injury after striking the road surface and became unconscious. Instead of stopping to assist or identify himself, the rider of the red scooty fled the scene immediately after the collision.

In view of the above, I humbly request you to kindly direct the concerned authorities to review and preserve the CCTV footage from the surveillance cameras installed at or around Keishampat Junction at around 4:30 PM on the date of the incident. The footage is likely to help identify the offending vehicle and rider and will be crucial for a fair investigation and appropriate legal action.

I shall be grateful for your prompt assistance in this matter.
