Subject:- Written report for registration of an FIR regarding theft
of a battery.

Sir,

I, ASI. RK. Chinglensana Singh of City-PS, hereby submit this report for taking up necessary legal action and registration of an FIR on the following facts:

On 08/08/2026 at about 1:00 AM, while conducting night patrolling duty in and around Paona Bazar area, our patrol team reached near Paona Mouth Police Booth, where one unknown person was noticed coming in a suspicious manner while carrying a battery.

On seeing the said person, he was directed to stop for verification. However, he attempted to escape by taking advantage of the darkness. The patrol team immediately searched the nearby area, during which the said person was found hiding underneath a parked car. He was accordingly detained at the spot for verification along with one battery in his possession.

On questioning, the person disclosed his identity as Md. Sarif (19 years), S/o (L) Md. Akber Khan of Lilong Toel Khul. During verification and questioning, he disclosed that he had stolen a battery from one Honda Activa that was parked on the road side of Keishampat Thokchom Leikai along Mayai Lambi at about 12:30 am.

The said person, namely Md. Sarif, along with the battery found from his possession, was detained at the spot and subsequently brought to City Police Station at about 2:00 AM on 08/08/2026 for further necessary legal action.

In view of the above facts, it is requested that a case/FIR may kindly be registered under the appropriate provisions of law against the said person, Md. Sarif, and necessary investigation may be taken up.
