Sir,

I have the honour to state that I am a salesman in the Chill Out Hotel located at MG Avenue Thangal Bazar, Imphal.

That today i.e. 09/08/2026 between 4:30 pm to 5:00 pm, my money bag/wallet containing one Aadhar Card, one PAN Card, one ATM Card and a sum of Rs. 350/- was stolen away by two Non Manipuri youths later identified as Rohan Kumar Sahani (19) S/o Rajmohon Sahani of Bihar A/p Mantripukhri Naga Ching and Abdul Kaif (22) S/o Abdul Karim of Bihar A/p Nagamapal Kangjabi Leirak while I was busy in washing utensils inside the said Galli where washing of utensils was done. The said wallet was kept on the rack which was attached at the wall of the said galli. The two Non Manipuri were well known to me as they usually come to the Hotel.

That on the same day at about 5:30 pm, Rohan Sahani was seen near MG Avenue and he was detained and asked for the wallet. On asking, he disclosed that he and Abdul Kaif took the said wallet from inside the said Galli and after taking the money, they threw the wallet inside Imphal War Cemetery. Abdul Kaif was also turn up and on their pointing out, recovered the wallet from War Cemetery.

Hence, the two Non Manipuri and the wallet are hand over to City-PS for taking necessary legal action against them.

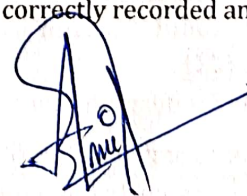
