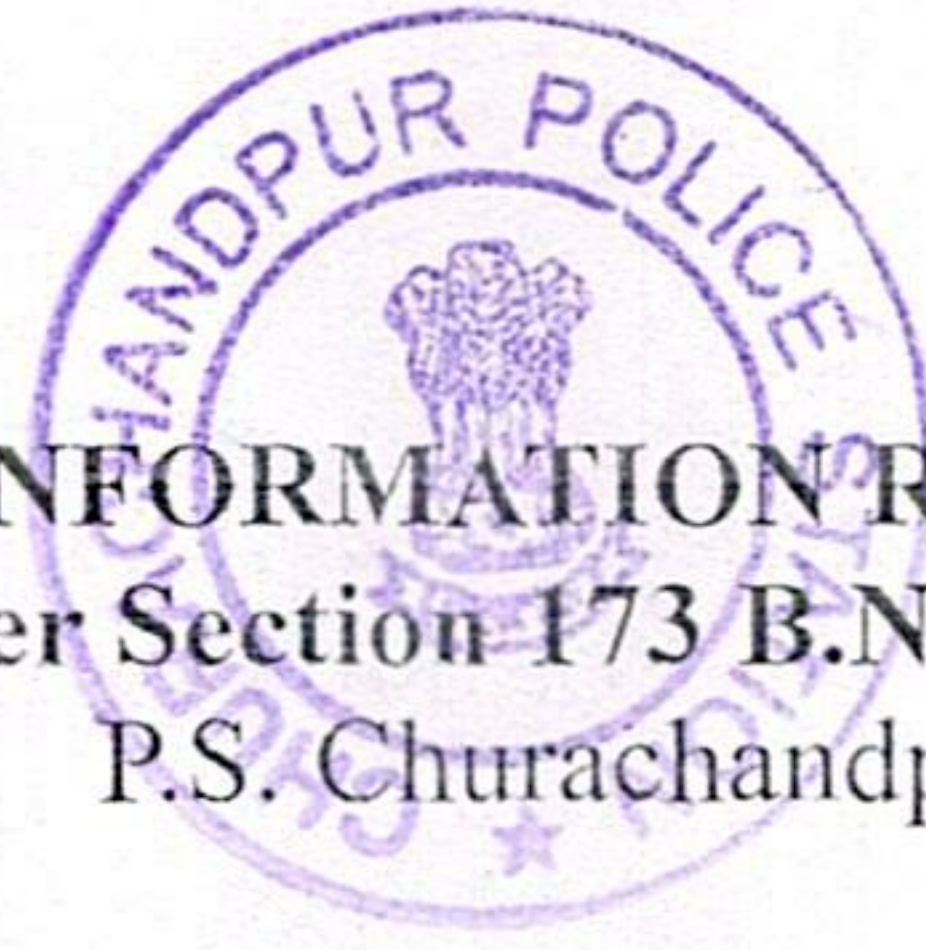

I am to submit a report on the recovery of arms, ammunitions and other tactical items by officers & personnel of 1st IRB BHQ at around 08:30 am on 14th July, 2026 (Tuesday) while conducting area domination and foot patrolling duty in and around Gothol-Phouljang Village under the direct supervision of Shri Rommel Gangte, MPS, Asst. Commandant, 1st IRB and overall supervision of the Shri Paukhanmung Gwite, MPS, Commandant, 1st IRB.

That, as per CO, 1st IRB Order No. A-1/23/2026-1st IRB/724 dated 14/07/2026, the undersigned along with 6 ORs from 1st IRB BHQ under the command of Shri Rommel Gangte, MPS, and personnel of 1st IRB Gothol Post under the command of Jem. Khaineikhup Vaiphei, JC/No. 952 of 5th MR (presently reported at 1st IRB), conducted a joint area domination and foot patrolling in and around Gothol - Phouljang Village, Churachandpur from 0600 Hrs onwards. 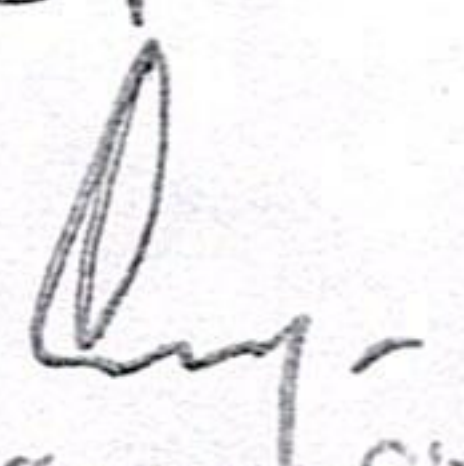
