Today, i.e. 22/7/2026 at @ 11:45 am received an information from reliable source that some contraband items will be delivered at Songja Khopi, Churachandpur. A written information about the received information was submitted to the SP-CCPur. Therefore, as per direction from SP/CCpur a strong Police team comprising a team of CCP-PS and a team of WPS-CCP rushed to the area and conducted a proper vigilance at the area. Further information was received from sources that the suspected individual carrying a contraband items is taking shelter at the rented house of Chongpi at Songja Khopi. Therefore, a Police team comprising of women police rushed to the spot. On arrival, house search was conducted in presence of Magistrate and two independent witnesses namely -Ngam S Gangte Secretary Village Authority, Songja Khopi and J Paul Mate Youth Club Vice President, Songja Khopi, Churachandpur and after obtaining permission from the owner of the house. During the House search the suspected individual was found present inside the house. On proper search of the bag the suspected individual was carrying, suspected brown sugar

packed in four white transparent polythene pouch were recovered from the possession of accused namely H Tinnei Thadou (52) w/o H Hemkhomang Thadou of Lonpi Khonou, Sugnu Chandel District. The recovered items were marked as A, B, C and D and weight by a weighing scale and recorded as under:-

A- 397 grams, B-384 Grams, C-380 Grams and D- 407 grams.

The total weight of the recovered contraband items is 1568 grams.

The under noted items were seized from the possession of the accused person at 1:20 pm.

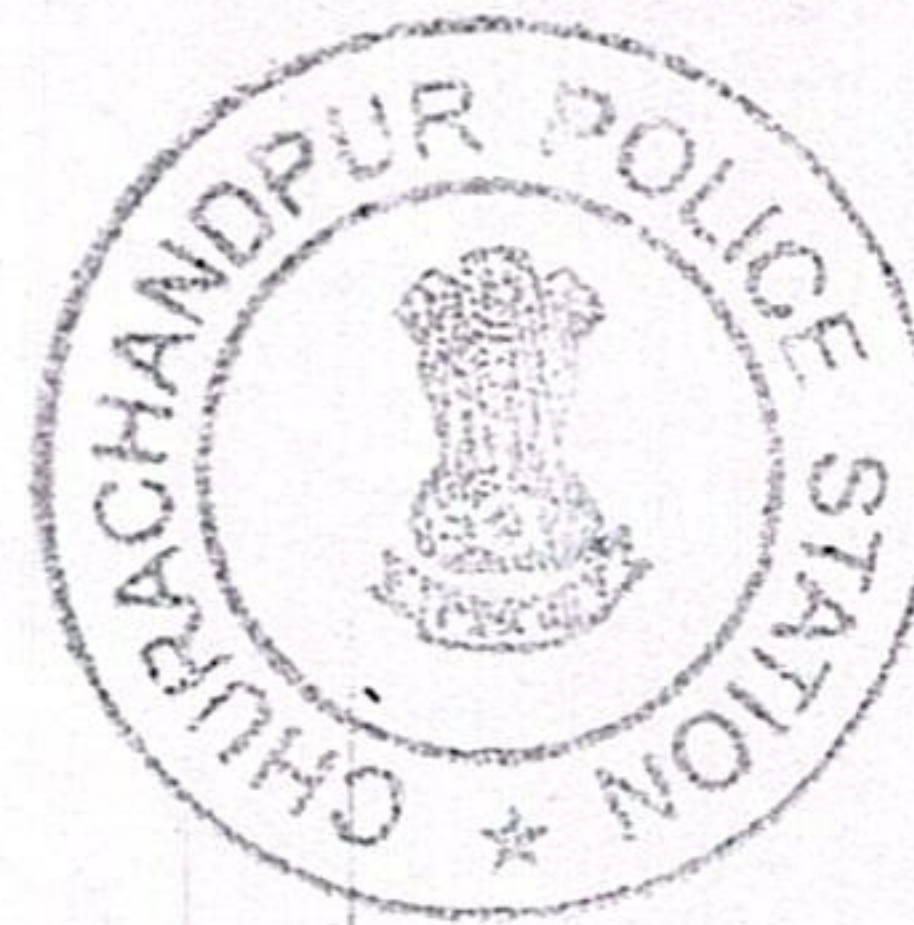
