Sub: Report regarding seizure of suspected Brown Sugar/Heroin powder and arrest of accused.

Sir,

I have the honour to report that today, i.e. **14/08/2026**, at about **4:00 PM**, reliable information was received from a source regarding the presence of contraband substance, suspected to be **Heroin powder/Brown Sugar**, in a house located opposite the approach road of B. **Vengnom, Tuibong, Churachandpur**.

On receipt of the information, a **combined team comprising personnel of CCP-PS, Women Police personnel and column of 37 Assam Rifles** was constituted for conducting a joint operation under the supervision of **Shri Jay Barange, SDPO/CCP-PS, IPS**. Requisition was also made to the **District Magistrate, Churachandpur**, for deputing an Executive Magistrate at the place of search.

After identifying and ascertaining the said house, a search operation was conducted in the presence of the Executive Magistrate, **Shri L. Thanggoulen Khongsai, SDC, DC Office, Churachandpur**.

During the course of search, **two nylon sacks**, one white in colour and the other yellow in colour, were found inside the living room of the house, placed beside the bed. On opening and checking the sacks, **197 soap cases containing suspected contraband Brown Sugar/Heroin powder** were found.

The house was occupied by **Mrs. Nemneihoi Touthang, aged 26 years, W/o Paotinmang Touthang, resident of Leikot Village, Khamenlok, Kangpokpi District, Manipur, presently residing at Tuibong Village, Churachandpur** and her minor son. During the search, she admitted that the recovered substance was Brown Sugar/Heroin and stated that it belonged to her.
