Subject: Report.

Sir,

I have the honour to report that on 03.07.2026, I purchased one Maruti Swift car bearing Registration No. MN01AW9541 from one Kongkham Irabanta Singh (30) years, S/o K. Imoba Singh of Bamon Kampu Mayai Leikai, Imphal East, for a consideration amount of Rs. 3,50,000/- (Rupees Three Lakhs Fifty Thousand only) by executing a sale deed in the presence of the witness, namely, Saikhom Rajesh Singh (35) years, S/o Late Saikhom Kumar Singh of Heirok Part II, Thokchom Bazar, Shaikhom Leirak. The entire process of sale and purchase was completed at my residence on the same day, i.e. 03.07.2026.

At the time of the transaction, Kongkham Irabanta Singh produced an India Non-Judicial Stamp Paper containing the purported sale agreement relating to the above-mentioned vehicle. The document stated that the said vehicle had earlier been purchased by Kongkham Irabanta Singh from Telem Lotrababu Singh, S/o Telem Ingocha Singh of Yairipok Khoirom Makha Leikai, on 05.03.2026, bearing the signatures of the seller, purchaser, and the witness, namely, Saikhom Rajesh Singh.

Later, it came to light that all the documents produced by Kongkham Irabanta Singh were found to be forged and fabricated.

It is alleged that Kongkham Irabanta Singh and Saikhom Rajesh Singh prepared and used these forged documents with the intention to deceive and dishonestly induce me to purchase the vehicle, thereby cheating me by committing forgery for the purpose of cheating, using forged documents as genuine, and committing criminal breach of trust for their wrongful gain and my wrongful loss.

It is, therefore, requested to kindly take up legal action against the above two individuals as per law.
