I have the honour to report that, one Scooter/vehicle Honda Activa 6G STD bearing the following details: Registration No. MN01AJ5587, Chassis No. ME4JF913BLW040310, Engine No. JF91EW0040245, Model-2019 & Colour: Gray, recored/Registered in the name of one Akoijam Kisson Singh S/o A. Gandhi Singh of Thounaojam Awang Leikai BS Road Thounaojam, Kakching.

On 31/07/2026 at around 5.30 pm, I parked the above mentioned Scooter infront of my friend's chicken centre named as "Jack Chicken Centre," Thoubal Awang Leikai under proper lock to assist his work. On the next day i.e 1/8/2026 at around 6.00 am, I found that the Scooter was missing from the place where it was parked. I immediately searched in the surrounding area but the Scooter could not be traced. It is learnt that unknown person had stolen away the Scooter.
