11. First Information contents:

Today i.e. 01/08/2026 at 10.25 pm, received a reliable information that on the same day at around 10:20 pm, a road traffic accident occurred at Khangabok Sanilou area near 3rd IRB along NH102 thereby, one Hyundai i20 Asta bearing regn. No. MN06LX6961 driven by unknown driver which was proceeding from Wangjing towards Thoubal dashed into two vehicles after crossing the road median i.e. one Maruti Van bearing regn. No.MN05A8007 driven by unknown driver and another one Honda Activa bearing regn. No.MN01AD1175 ridden by unknown rider one after another, both of which were proceeding from the opposite direction due to rash and negligent driving on the part of the driver of the i20 Asta car. As a result of which, a total of 8 persons i.e. 3 occupants of i20 Asta and 1 occupant of Maruti van and driver & rider and 2 pillions of of Honda Activa sustained injuries and were evacuated to hospital for medical treatment. The 3 (three) vehicles were badly damaged. Hence the case.
