Subject: Report

Sir,

I am to report that on 02/08/2026 at around 3.30 am, received a reliable input corroborated with our own source regarding hideout of some arms and ammunitions suspected to be concealed by some unknown arm miscreants at Ikop Pat near Arong Turel area under Thoubal-PS. Immediately, a combined teams of CDO, BPR led by Inspt. Parlung Arthur Roel, OC, CDO-BPR, assisted by SI S. Ojit Singh, Hav. No. 1299055 Kh. Kunje Singh, Hav. No. 1299078 S. Hementa Singh, Hav. No. 15007648 RK. Manjit Singh, HC. O. Jayenta Singh, HC. N. Somorjit Singh comprising with Hav. no. 1299418 Md. Islamuddin, Hav. No. 1299017 Samuel Kamei, Hav. No. 0920001230 Ch. Bobo Singh, HC Y. Shanta Singh, Rfn. No.112005770 N. Robachandra Singh, Rfn. No. 112010982 A. Norjit Sharma, C/No. 1815040 Narendra Ningombam and C/No. 1815029 Loyangamba Asem of CDO/BPR under the supervision of Addl. SP (Ops), Bishnupur and under the overall guidance of SP Bishnupur conducted an extensive search operation at Ikop Pat area after giving due information to the concern authority. In that, the following arms cache were recovered from the dense area at Ikop Pat on the Northern side of the Arong river which were kept concealed in a blue wooden box:

1. One INSAS Rifle regd no.18244908.
2. One INSAS Rifle regd no.18323691.
3. One MP-5 sub machine gun regd no.62-435650.
4. One SLR Rifle regd. 1A1/S6369.
5. One .303 Rifle regd.1949 no. 1 MK-3.
6. One .303 Rifle regd. no. 4 MK-173(F) FIR.
7. Two nos. Telescopic scope.
8. One AK Magazine.
9. Two nos of INSAS magazines.
10. One no. of MP-5 magazine.
11. One no. of INSAS LMG magazine.
12. Two nos. of .303 magazines.
13. One no. of SLR magazine.
14. One no. of smoke bomb.
15. Three nos of .303 charger guide.
16. 102 nos of AK ammunitions.
17. 87 nos. of .303 Rifle ammunitions.
18. 110 nos. of 5.56 INSAS ammunitions.
19. 80 nos of 7.62 SLR ammunitions.

The above-mentioned cache of arms and ammunitions, suspected to have been concealed by unknown armed miscreants, was recovered and seized at 7.55 a.m. However, no person was apprehended during the operation. The extensive search operation was concluded at about 8.20 a.m. The search and seizure operation/process were recorded videography through e-Sakshya application.

Thereafter, the seized articles were handed over to Thoubal-PS for taking further necessary legal action. Regard.
