Sir,

I have the honour to report on 10/08/2026 at around 8.30 am, I along with my husband namely, Wahrenbam Arjun Singh, 42yrs went to work at JNIMS, Porompat after properly locking our house gates (i.e Inrance gate, rear gate and backside gate). When we returned home at around 3.15 pm, it is found that the key locks of the three gates at the house premise were broken and the gates were left open. . Accordingly, we entered there and searched the entire house thoroughly. During searching, it was discovered that a gold rignfinger amounting to 2 sans worth about Rs. 70000/- which was kept in the Dressing Almirah in the entrance room of the house was missing. Further, Scooter Honda Activa 6G DLX bearing Regn. No. MN06SE0044, Chassis No. ME4JF914DMG460432, Engine No. JF91EG1459391, Model-2021, Colour: Pearl Spartan Red 2 & Worth about Rs.90,000/- recored/Registered in the name of one Changamayum Analakshmi Devi D/o Chongtham Angoubi of Chingamakhong Chongtham Leikai, Imphal West parked at the house Varandah was reported missing. Then, we immediately searched in the surrounding area but it could not be traced. It is learned that unknown persons had entered our house by breaking the key locks of the gates and had stolen away the Scooter and jewellery while we were away.

It is therefore, requested to kindly take up necessary legal action in this regard.
