11. First Information contents: Today i.e. 11/8/2026 at 9:10 pm, received an information that on the same day i.e. 11/8/2026 at about 9:00 pm, one Honda Activa Bearing Regn. No. MN01AF8220 proceeding from Khekman towards Thoubal side along MI Road collided with one Tata Magic bearing regn. No. MN01X9130 proceeding in the opposite direction at Iroipat area along MI Road due to rash & negligent riding/driving on the part of both unknown rider & driver. As a result of it, rider and one unknown pillion of the Honda Activa sustained injuries and evacuated to hospital for medical treatment. The Honda Activa was damaged while the Tata magic was partially damaged. Hence the case.
