Subject: Information regarding an assault incident involving two patients at our rehabilitation centre

Sir/Madam,

I respectfully wish to inform you that on 16-08-2026 at approximately 5:30 am, an unfortunate incident occurred at our rehabilitation centre. One of the alcoholic patient namely N Juris Singh from Kakwa Naorem Leikai who is also a mental health patients suddenly became aggressive and physically assaulted another patient namely Kh Ibomcha Meitei from Mahabali Road who was staying at our centre.

As a result of the incident, the patient sustained injuries. Our staff immediately intervened and provided necessary assistance. The injured patient was taken to **Advance Hospital** for medical treatment and further observation.

We would also like to state that we could not informed you immediately as we were occupied in taking him to District Hospital, Thoubal and thereafter to Advance Hospital, Imphal which was follow by arranging a meeting between the two families and counseling them to arrive at an amicable solution.

We are submitting this information to your good office for your kind information, and for any future course of action and for ensuring the security of our organization, should the situation so demand.

Kindly take note of the matter and do the needful.
