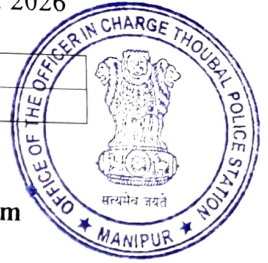

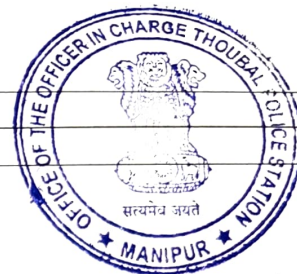

Sir,

I have the honour to report an incident of assault that occurred today i.e. 26/08/2026 at around 5.30 pm, at Moijing Awang Leikai, Thoubal. That, my nephew namely Md. Abash Khan (28) yrs S/o Md. Azad Khan of Moijing Awang Leikai, Thoubal while walking around the road at Moijing Awang Leikai, Thoubal nearby his house was physically assaulted by one Md. Mustaque Khan (28) yrs S/o (L) Md. Tasirman of Moijing Awang Leikai, Thoubal after which he (Md. Mustaque Khan) was incited by one Md. Aslam Khan (50) yrs S/o Haji Kadir of Moijing Awang Leikai, Thoubal. That, one Md. Mustaque Khan has used a sword while committing the offence and stabbed onto the head and neck of my nephew namely Md. Abash Khan without giving any valid reason resulting cut injury. Further, he was taken to Noor Hospital Lilong and received medical treatment.

It is therefore requested to kindly take necessary action in this regard.
