I have the honour to report that on 27/8/2026 at about 8:00 am, I left my residence to travel to Thangmeiband. The purpose of my visit was to deliver essential edible items to my daughter who is currently residing there for her studies.

After completing my errand, I returned home at around 12:10 pm on the same day. Upon my arrival, I discovered that my wife ~~wife~~ Huidrom Nanao Devi @ Premita @ Bibicha aged about 43 years w/o H. Tomba Singh of Uyal Awang Leikai, Thoubal District was missing from the house.

I have searched her in and around our residential premises as well as throughout the neighboring localities. I have also reached out to our relatives and acquaintances, but despite my best efforts, her whereabouts remain completely unknown.

Given the sudden and highly unusual nature of her disappearance from our home, I strongly suspect that she may have been abducted by unknown miscreants and concealed at an unknown location against her will. At the time of her disappearance, she was in possession of a mobile phone with the contact number 9862764988. However, all our subsequent attempts to establish contact with her have been unsuccessful as the device has remained continuously switched off.

It is therefore requested to kindly take necessary action in this regard.
