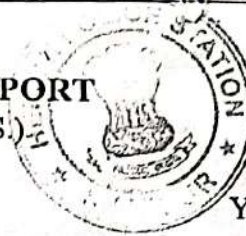

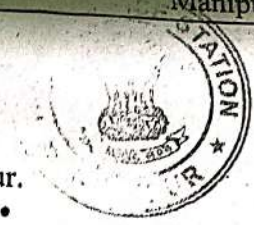
Subject: -Missing Report-reg.

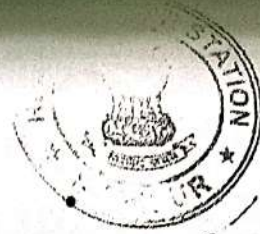
