Subject: Complaint report regarding cheating and fraudulent mortgage of a motor vehicle by Ningthoujam Ningthouremba Singh @ Lemba and others.

Sir,

With due respect, I have the honour to submit the following facts for your kind consideration and necessary legal action:

That, on 12/06/2026, one Ningthoujam Ningthouremba Singh @ Lemba, S/o (L) N. Irabot Singh of Heirol Part-I Heituppokpi, along with two other individuals, namely (1) Soibam Ibomcha Singh of Bamon Kampu, Imphal

East District, Manipur, and (2) Khumanthem Bhim Singh @ Boboy, S/o Kh. Premjit Singh of Heirok Part-II Bazar, Mamang, approached me in connection with the mortgage of one motor vehicle, namely TATA ALTROZ XZ+ 1.2 RTN BS6, bearing Registration No. MN01AW7933, for a consideration amount of Rs. 3,20,000/- (Rupees Three Lakhs Twenty Thousand only), stating that the money was required to meet their personal financial difficulties.

Thereafter, believing their representation to be genuine, I agreed to their request and handed over a sum of Rs. 3,20,000/- (Rupees Three Lakhs Twenty Thousand only) to them. In return, they handed over the said vehicle along with its relevant documents to me as security against the said amount. They further assured me that the entire amount would be repaid within one month from the date of the mortgage.

However, despite the expiry of the agreed period, they failed to repay the said amount, and the vehicle is still in my custody. Subsequently, I came to know that the said vehicle is actually registered in the name of Sorokhaibam Melody Devi, who is the registered owner of the vehicle. They mortgage the said vehicle to me without any knowledge/consent of the registered owner, Sorokhaibam Melody Devi.

It has now come to my knowledge that Ningthoujam Ningthouremba Singh @ Lemba, Soibam Ibomcha Singh and Khumanthem Bhim Singh @ Boboy had intentionally and dishonestly misrepresented the facts to me and induced me to part with a sum of Rs. 3,20,000/- (Rupees Three Lakhs Twenty Thousand only) by falsely representing that Soibam Ibomcha Singh was authorised to mortgage the said vehicle.

Furthermore, two other individuals, namely (1) Golmei Shanti Kabui, aged about 40 years, S/o Shanti Kabui of Irilbung Kabui Keirao Chingdong, Keirao, and (2) Akoijam Universe, aged about 26 years, S/o A. Basanta of Bamon Kampu Mayai Leikai, were also allegedly involved in the said illegal and fraudulent transaction.

In the several times, I went to the house of Ningthoujam Ningthouremba Singh @ Lemba, S/o (L) N. Irabot Singh of Heirok Part-I Heituppokpi, to enquire about the matter and demand repayment of the said amount. However, upon reaching his house, he allegedly threatened me by using abusive and threatening language and by showing deadly weapons.

In view of the above facts and circumstances, I therefore request you to kindly enquire into the matter and take up necessary legal action against the above-named persons in accordance with law.
