Today, i.e. 23/08/2026 at around 07.35 pm received an information that on the same day at around 07.30 pm, one Duster brown in colour, bearing registration No. MN43AN 5792 which was proceeding from Sapam towards Khongjom Bazar and one Royal Enfield steel in colour bearing registration No. MN01AN 4378 which was proceeding from Kakching side towards Wangjing side meet a road accident at Khongjom Bazar due to rash or negligent driving on the part of unknown driver of above Duster (.). As a result of which, the unknown rider of Royal Enfield sustained serious bleeding injuries on his person and evacuated to Hospital, for medical treatment. Both the involved vehicles were also partly damaged.
