Sir,

I have the honour to report that today, i.e. 31/07/2026, specific inputs were received, which was also corroborated with that received from 46 Assam Rifles regarding the presence of a cadre of the banned organization KCP (Noyon) at Pallel Leimanai Chingjin area under Kakching District. The input further indicated that the cadre was allegedly planning to plant bombs/IEDs in connection with the forthcoming Independence Day celebration on 15th August, 2026.

On receipt of the information, a team of CDO Unit, Kakching, under the command of Subedar Yengkhom Shaktishen Singh, OC/CDO Kakching, under the supervision of Shri Amarjit Singh Lamabam, MPS, Addl. SP (Ops), Kakching, and under the overall supervision of Smt. Priyadarshini Laishram, IPS, Superintendent of Police, Kakching, immediately rushed to the suspected location and conducted a search operation at Leimanai Chingjin area. During the operation, one suspected individual matching the description received in the input was detained near Pallel towards Bijoypur for verification.

On preliminary examination, the detainee identified himself as Sarangthem Rahul Singh (32) yrs, S/o (L) S. Bir Singh of Pallel Mayai Leikai. During sustained interrogation, he disclosed that he is an active cadre of the banned organization KCP (Noyon), holding the rank of 2nd Lieutenant of the 21st Batch, and stated that he had undergone training at Tanai, Myanmar. He further revealed that he had joined the organization through one S/S Lance Corporal Wanglen of the same banned organization. He also disclosed that he was previously arrested by CDO Moreh in 2014 and was released on bail. Subsequently, he was arrested again by Assam Rifles at Dimapur in February, 2025 and was released on bail.

During further interrogation, he was found to be highly suspected to be involved in planning subversive activities, including the said planting of bombs/IEDs in connection with the forthcoming Independence Day celebrations. Based on his disclosure and the available incriminating evidence, he was arrested at the spot at 06:00 pm after observing all legal formalities.

From his production recovered two Mobile Phone i.e. (1) One Redmi Note 12 Pro 5G bearing IMEI1-863393067598198 & IMEI2-863393067598206 with two SIM one Jio SIM No. 7676066825 and one Airtel SIM No. 7085167478 (2) One Plus Nord CE4 bearing IMEI1-867296073062396 & IMEI2-867296073062388 along with two SIM, one Airtel SIM No.7085204191 & one Jio SIM No.9113071822 were sized from the spot at 06:10 pm by observing all legal formalities and videography of the same was done at the spot.

The arrested individual along with the seized items and arrest Memo, arrest intimation, ground of arrest are handed over to you for taking further necessary action.

From his production recovered two Mobile Phone i.e. (1) One Redmi Note 12 Pro 5G bearing IMEI1-863393067598198 & IMEI2-863393067598206 with two SIM one Jio SIM No. 7676066825 and one Airtel SIM No. 7085167478 (2) One Plus Nord CE4 bearing IMEI1-867296073062396 & IMEI2-867296073062388 along with two SIM, one Airtel SIM No. 7085204191 & one Jio SIM No. 9113071822 were seized from the spot at 06:10 pm by observing all legal formalities and videography of the same was done at the spot.

The arrested individual along with the seized items and arrest Memo, arrest intimation, ground of arrest are handed over to you for taking further necessary action.

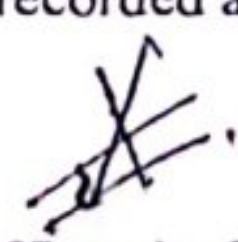
