Facts of the Case:

1. That, on 3rd June, 2026 at around 12:10 P.M, my father namely Leitanthem Angou Singh went to Kwakeithel Thiyam Leikai Youth Organization to register a complaint regarding the nuisance created by the accused who illegally sold liquor till late night every day.
2. That, a setting was organised by the secretary of the said local club, however, the accused did not bother to listen my father and my father requested to arrange a joint setting of two local club of Soibam Leikai and Thiyam Leikai.
3. That, the accused boldly threaten my father by saying that he will kill him if my father keep on complaining to local clubs.
4. That, as aged person my father wishes not to engage in verbal conversation with the accused person and went out to leave of the club.
5. That, when the my father was about to start the two-wheeler vehicle, suddenly the accused person jumped into my father with pointed stone and hit my father without any provocation with a clear attempt to hit my father on his head. However, luckily the stone hit on the bridge of nose and cause grievous hurt to my father.
6. And thereafter, my father was rushed to the RIMS Hospital for treatment and MLC bearing No. 26/2689 was recorded. During the treatment it was examined that the bridge of nose, swelling, active bleed and need to be done OT to clear the blockage.

7. That, the accused person keeps on shouting to my father in front of my house and shouting 'why didn't you file F.I.R till now' 'go anywhere I don't care, I will beat you again'
