Sir,

I respectfully submit a report that on 11/06/2026, between 8:10 a.m. and 8:20 a.m., my husband, Shri Haobam Satyajoti, aged about 52 years, was riding his bicycle from RIMS Hospital towards Langol View Clinic, Imphal West. When he reached near Imoinu Hotel, close to RIMS Road Crossing, Imphal West along the RIMS Road, an auto-rickshaw bearing Registration No. AS11EC-5874 (black and yellow in colour), coming from the same direction, suddenly hit him from backside of the bicycle due to the rash and negligent driving of the unknown auto driver.

As a result of the accident, my husband sustained multiple injuries over his right shoulder, right elbow, occipital region of the head, and right cheek, along with a compression fracture of the L1 vertebra. His bicycle was also damaged in the accident. Immediately after the accident, he was evacuated and admitted to RIMS Hospital for medical treatment.

I, therefore, request your good office to kindly take necessary action in accordance with law and conduct an inquiry into the matter.

For this act of kindness, I shall remain grateful.
